SUMMERSET, SOUTH DAKOTA**

NOTICE IS HEREBY GIVEN, that the **City of Summerset**, South Dakota, will receive bids until **June 14<sup>th</sup>, 2018** at the hour of **2:00 P.M. MDT** in City Hall, 7055 Leisure Lane, Summerset, SD 57718 for the furnishing of materials, labor, equipment and skill required for the purpose of construction of the specified street maintenance and incidental items in and for said Summerset, South Dakota, as is more fully described and set forth in the plans and specifications therefore, which are now on file in the office of the City Finance Officer, City Hall, Summerset, South Dakota. Bids shall be publicly opened and read on the **14<sup>th</sup> of June 2018** at the hour of **2:05 P.M. MDT** at the City of Summerset, South Dakota, City Hall.

Bids will be received on the following approximate quantities and types of work:

2018 Street Maintenance: Mobilization, 1 LS; Traffic Control, 1 LS; Inlet Protection, 5 EA; Sodding, 11 SY; Unclassified Excavation, 18 CY; Remove Type E Top Slab and Throat, 1 EA; Remove Sidewalk, 63 SY; Remove Asphalt Concrete, 230 SY; Cold Mill Asphalt Concrete, 9504 SY; Remove Curb & Gutter, 109 LF; Adjust Manhole, 10 EA; Adjust Gate Valve, 1 EA; Type E Inlet Top Slab and Throat, 1 EA; Aggregate Base Course, 96 TON; Structural Fill, 18 CY; 4" Concrete Sidewalk, 558 SF; 2" Asphalt Concrete Overlay, 1045 TON; Asphalt Concrete, 62 TON; Concrete Curb & Gutter, 109 LF

A pre-bid conference will be held for this project on **June 7<sup>th</sup>, 2018** at **2:00 P.M. MDT** at Summerset City Hall, 7055 Leisure Lane, Summerset, SD 57718.

All bids are to be submitted on the basis of cash payment for the work and materials, and each bid shall be accompanied by a certified check or cashier's check or draft for five percent (**5%**) of the amount of the bid, such check to be certified or issued by either a state or national bank and payable to the **City of Summerset, SD** or in lieu thereof, a bidder's bond in a sum equal to ten percent (**10%**) of the full amount of the bid, executed by the bidder as principal and by a surety company authorized to do business in this state, conditioned that if the principal's bid be accepted and the contract awarded to him, he, within fifteen (15) days after notice of award, will execute and effect a contract in accordance with the terms of his bid and a contractor's bond as required by the laws of the State of South Dakota and the regulations and determinations of the **City of Summerset**, South Dakota.

A single contract shall be awarded on the basis of the low bid submitted by a responsible and responsive bidder for the aggregate sum of all bid items.

All bids will be contained in a sealed envelope, plainly marked showing that such envelope contains a bid for the above project. In addition, the bidder shall place upon the exterior of such envelope the following information:

1. The work covered by the bidder
2. The name of the bidder
3. Separate envelope containing bid bond and a copy of Contractor's License or Renewal Certificate.
4. Acknowledgement of all Addenda.

Failure to submit bids according to these instructions may be cause for bids to be rejected and returned.

The work on the improvements shall be complete by **September 28<sup>th</sup>, 2018**.

The **City of Summerset, SD** reserves the right to reject any and all bids to waive any informality in any bid, to hold all bids for a period not to exceed **thirty (30)** days from the date of opening bids, and to accept the bid deemed most favorable to the interest of the City of Summerset.

Should the Contractor fail to complete the work within the time required herein or within such extra time as may have been granted by formal extensions of time approved by the Owner, there will be deducted from any amount due the Contractor the sum of **\$325** per day for each calendar day and every calendar day that the completion of the work is delayed. The Contractor and his surety will be liable for any excess. Such payment will be as and for liquidated damages and not as a penalty.

All bidders are invited to be present at the public opening of the bids.
